BAY 7, mostly nurse AMANDA, we have met before. Bay felt more spacious than bays I have previously been in.

Not as busy in assessment & they had a more thorough protocol than previously. This MAY cost \$66:00.

Amanda helped me with tie-robe did ECG, put BP monitor on right arm & oxygen clip on my right index finger. She also did a finger prick to check blood sugars - 4.6 according to her a bit low but she would keep a check on me (?) Not had this done on previous admissions.

Susan arrived first, Harmeet 15 mins later.

Harmeet inserted the cannula into right hand, I prefer left forearm, less pain as it doesn't use 'moving fingers'!

All went as usual.

Greg came back from visitor room, Susan told him she was going to get some bloods done & that I should make an appointment for 6 weeks time.

Amanda did BLOODS in left arm despite me telling her to do them through my cannula, she said that shouldn't be done as I had had Propanolol through it. Harmeet popped his head in, saw what she was doing & said 'next time I need bloods done tell him & he'll do it through my cannula'.

BLOODS:

Potassium. Magnesium. (E Us) - Electrolytes. INR.

Had water, shared a few cold sandwich triangles with Greg, gave cuppa tea to Greg, pulled off most of my various stickies & left for home.
